Hosting a Speaker of a Religious Faith

- Facilitation Guidelines -

The **Bridges of Faith Trialogue** encourages interfaith learning through conversation and educational forums where a member of one religious faith serves as a guest lecturer or speaker in another house of worship or a civic venue. These exchanges create exposure and breed better understanding of the tenets, practices and culture of all religions in our region and foster interfaith understanding and respect. These forums often, and with good reason, delve into sensitive topics and solicit challenging questions asked in good faith. However, they can also draw the occasional hostile or unruly audience member, who seeks only to disrupt the forum, discredit the speaker, and distract the audience. These best practices for hosts and moderators were compiled to serve as a guide for maintaining a productive atmosphere of learning and mutual respect, and for mitigating any unforeseen inappropriate or offensive disruptions. BEFORE THE PROGRAM:

- Before the program is advertised, the host and/or moderator should talk with the guest speaker so that both parties are clear on the focus of the talk (be specific!) and what topics are off limits or offensive. Also talk through the most productive method for the question and answer session. For large audiences or particularly controversial topics, providing the audience with index cards and allowing the moderator or host to pick the questions may be a more effective format than allowing for an open question and answer session.
- Promotion of the program should be specific, so that only an audience interested in that specific topic attend. (Caution: Using social media and other public outlets to publicize your program creates the risk of attracting unwanted visitors.)
- In the case of a particularly sensitive or controversial topic, the host and/or moderatormaywanttoconsiderhiringsecurityor consulting with local law enforcement, either of whom could assist in the case that a disruptive individual refuses to leave when asked repeatedly.

• Before the program begins, the host and/ or moderator should again speak with the presenter to be sure he or she understands what questions or comments are offensive or off limits. The host and/or moderator and the speaker should develop a plan so that the speaker can, in the moment, nonverbally or verbally communicate with the host or moderator if an offensive question or comment arises. - This discussion is for the purpose of learning. A respectful environment is essential for effective learning and communication. Anyone who behaves in a way that disrespects the forum or the speaker will be asked to leave the forum.
- Please note that the speaker, whether clergy or laity, does not speak on behalf of an entire religion, but only as an individual adherent of that faith. Likewise, he/she may not be a religious scholar or an authority on doctrine or practice, simply someone with personal experience in living his/her faith. If the speaker is a religious scholar, understand that religious scholarship allows for diversity of interpretation. Finally, it is important to acknowledge that all religious traditions contain tremendous diversity of theology and practice, ranging widely from liberal/reform to literal/orthodox.
- Please listen to understand, and not to judge. We are gathered with open minds and hearts, not to compare, contrast or otherwise evaluate the speaker's faith.
- Please refrain from engaging in a way that debates the merits of our respective religions. When we move into the Q & A session, following the speaker's remarks, it is inappropriate to advocate one faith over another or pose questions that are argumentative. Inquiries should be out of a genuine desire to seek a deeper understanding of the speaker's faith.
